COMMITTAL ORDER

Accused is in custody. He is produced before me through video conferencing by the Jail Authorities. He has been charged with the offence punishable under sections 115(2), 69 of The Bharatiya Nyaya Sanhita, 2023 of which section 69 of The Bharatiya Nyaya Sanhita, 2023 is exclusively triable by the Court of Session. The copies of police report and other documents as specified in Section 230 of The Bharatiya Nagarik Suraksha Sanhita, 2023 have been supplied to the accused. The accused has made the arrangements of his defence counsel. The case will have to be committed to the Hon'ble Court of Session. Hence, the order :-

ORDER

1. The case be committed to the Hon'ble Court of Session.
2. The accused is remanded to Magisterial Custody until commitment of the case and also during and until the conclusion of trial before the Court of Session vide section 232(a) and (b) of The Bharatiya Nagarik Suraksha Sanhita, 2023.

3. The Jail Authorities is directed to produce the accused before the Hon'ble Court of Session on receiving production warrant from that Court in Form No. IV, Chapter XXXIII of the Criminal Manual.
4. The record of the case, the documents and articles, which are to be produced, in evidence, shall be sent to the Court of Session.
5. The Police Station Officer, Malwani Police Station be directed to produce muddemal property in the Court of Session on or before 13/07/2026 positively.
6. The Public Prosecutor shall be notified of the commitment of the case to the Hon'ble Court of Sessions.
