



Order below Exhibit No.1

This is an application to grant heir-ship certificate in accordance with the provisions of The Bombay Regulation VIII of 1827.

2. Applicants submitted that, they are the legal heirs of deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge). Applicant no.1 is the daughter, applicant no.2 is the son, applicant no.3 is the daughter-in-law and the applicant no.4 is the grand son of the deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge). The applicant submitted that deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge) died on 20/09/2022 at Wadgaon Jangli, post Kelzar, Tah.Seloo and Dist.Wardha and the son of the deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge) that is Vilas Sitaram Nagrale died on 07/03/2022 at Kasturba Hospital, Sewagram, Dist. Wardha. The applicants are in need of legal heir-ship certificate for mutating their names on the immovable property as field property standing in the name of deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge). It is submitted that they are only beneficiaries and successor of deceased. It is the case of applicants that they are only legal heirs of deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge).

3. Applicant no.3 Jaymala Vilas Nagrale lead her evidence on affidavit at Exh.13 for themselves. In support of her application,

applicants have filed some documents and relied there upon i. e. the verified copies of Aadhar-cards of applicant nos. 3 and 4 at Exh.14 and 15 respectively and the verified copies of Aadhar-cards of applicant nos.1 and 2 at Exh.24 and 25 respectively, a copy of school certificate of deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge) at Exh.26, an copy of primary school certificate of deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge) at Exh.27, a copies of village form 7 (Adhikar Abhilekh Patrak) at Exh.28 and 29 respectively, a copy of village form 8 (Land holding record book) at Exh.30, a verified copies of death certificate of deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge) and Vilas Sitaram Nagrale at Exh.22 and 23 respectively and a copy of notice published in Newspaper “Dainik Punnyanagari” Dt. 25/09/2025 it is at Exh.16 and copy paper publication Bill at Article-A.

4. Perused the public notice issued by the applicants in daily local newspaper “Dainik Punnyanagari” Dt. 25/09/2025 filed on the record. Even after completion of one month of publication, no one has objected the application after issuance of public notice and proclamation.

5. Perused documents and records. It appears that, applicants are legal heirs of deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge). From death certificate, it is also reveals that, Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge) died on 20/09/2022 and the son of the deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge) that is Vilas Sitaram Nagrale died on 07/03/2022. It appears from evidence on record that applicants are only recognized heirs of deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge).

Hence, I do not hesitate in issuing here-ship certificate in name of applicants and passed following order.

ORDER

- 1) The application is allowed.
- 2) It is declared that, applicant no.1 Asha Sanjay Gawande, applicant no.2 Vikas Sitaram Nagrale, applicant no.3 Jaymala Vilas Nagrale and applicant no.4 Samar Vilas Nagrale are recognized heirs of deceased Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge).
- 3) Heir-ship certificate as described Under Section-III (Appendix-B) of The Bombay Regulation Act, be issued in name of applicants in pursuance of death of Kamal Sitaram Nagrale (Kamal Ramchandra Tamgadge) on payment of necessary Court fee.
