This is an application to grant heir-ship certificate in accordance with the provisions of The Bombay Regulation VIII of 1827.

2] Applicant submitted that, he is the legal heir of deceased Bhola @ Bholanath Tukaram Marpachi @ Kulmathe. Applicant is the brother of deceased Bhola @ Bholanath Tukaram Marpachi @ Kulmathe. The applicant submitted that deceased Bhola @ Bholanath Tukaram Marpachi @ Kulmathe died on 20/08/2017 at Mouza Dabha (Agargaon), Tah.Hingna and Dist.Nagpur. The wife of the deceased Bhola @ Bholanath Tukaram Marpachi @ Kulmathe that is Sindhubai @ Vanita Bhola @ Bholanath Marpachi @ Kulmathe is died on 03/11/2007 at Mouza Garamsur, Tah.Seloo and Dist.Wardha. The father of the deceased namely Tukaram Mahadev Marpachi died on 10/07/1990 at Mouza Dabha, Tah.Hingna and Dist.Nagpur and the mother of the deceased namely Kasabai Tukaram Marpachi died on 18/07/2006 at Mouza Dabha, Tah.Hingna and Dist.Nagpur. Applicant is in need of heir-ship certificate for the purpose of mutating his name on the immovable property standing in the name of his deceased brother and for Government and Semi-Government work. It is submitted that he is only beneficiaries and successor of deceased. It is the case of applicant that he is only legal heir of deceased Bhola @ Bholanath Tukaram Marpachi @ Kulmathe.

3] Applicant Shrawan Tukaram Marpachi lead his evidence on affidavit at Exh.09 for himself. In support of his application, applicant has filed some documents and relied there upon i. e. the verified copy of Aadhar-card of applicant at Exh.10, verified copy of death certificate of Bhola @ Bholanath Tukaram Marpachi @ Kulmathe and Sindhubai @ Vanita Bhola @ Bholanath Marpachi @ Kulmathe at Exh.11 and 14 respectively, a verified copy of tax receipt issued by Gram Panchayat Office at Exh.12, a verified copies of school living certificate of deceased Bhola @ Bholanath Tukaram Marpachi @ Kulmathe and applicant at Exh.13 and 15 respectively, an original copy of the tax assessment record book for the year 1993-94 at Exh.16, a copy of family member report given by the police patil at Exh.17, a letter from Gram Panchayat at Exh.18, a copy of notice published in Newspaper "Dainik Punnyanagari" Dt. 13/01/2026 it is at Exh.19 and copy paper publication Bill at Article-A and the verified copies of the death certificate of father of deceased namely Tukaram Mahadev Marpachi and the death certificate of mother of deceased namely Kasabai Tukaram Marpachi at Exh.23 and 24 respectively.

4] Perused the public notice issued by the applicant in daily local newspaper "Dainik Punnyanagari" Dt. 13/01/2026 filed on the record. Even after completion of one month of publication, no one has objected the application after issuance of public notice and proclamation.

5] Perused documents and records. It appears that, applicant is legal heir of deceased Bhola @ Bholanath Tukaram Marpachi @ Kulmathe. From death certificate, it is also reveals that, Bhola @

Bholanath Tukaram Marpachi @ Kulmathe died on 20/08/2017, the wife of the deceased Bhola @ Bholanath Tukaram Marpachi @ Kulmathe that is Sindhubai @ Vanita Bhola @ Bholanath Marpachi @ Kulmathe is died on 03/11/2007 and the father of the deceased namely Tukaram Mahadev Marpachi died on 10/07/1990 and the mother of the deceased namely Kasabai Tukaram Marpachi died on 18/07/2006. It appears from evidence on record that applicant is only recognized heir of deceased. Hence, I do not hesitate in issuing here-ship certificate in name of applicant and passed following order.

ORDER

- 1) The application is allowed.
- 2) It is declared that, applicant Shrawan Tukaram Marpachi recognized heir of deceased Bhola @ Bholanath Tukaram Marpachi @ Kulmathe.
- 3) Heir-ship certificate as described Under Section-III (Appendix-B) of The Bombay Regulation Act, be issued in name of applicant in pursuance of death of Bhola @ Bholanath Tukaram Marpachi @ Kulmathe on payment of necessary Court fee.
