

CNR MHWR06-000203-2021**Order below Supratnama Application Exh.3**

(Dt. 05/04/2021)

The present application has been filed for seeking the release of Splendor Pro Motorcycle bearing Registration no.MH-34 AF-2667 (Chassis no.MBLHA10AABHD04315 and Engine no.HA10EGBHD 23767) seized by the Police Station, Hinganghat in Crime no.8/2021 for the offences punishable U/s.354-D, 504 and 506 of I.P.C. The say of Investigation Officer makes it clear that the said vehicle has indeed, been seized by the police. However, the I.O. has submitted that, if it is released then it will be used in committing another offence. Ld. A.P.P has also objected to release the above vehicle in favour of the applicant as there is chances to repeat the offence.

2. Adv.Shri.Bhujade for the applicant has submitted that applicant is the owner of the said vehicle and he is ready to abide all the terms and conditions imposed by the Court. He has further prayed for the release of the said motorcycle.

3. Perused the documents filed by the applicant, i.e. copy of registration certificate of the abovesaid vehicle, which is in his name. The applicant has also filed copy of his Aadhar card as an identity proof. From the above documents, prima facie it is proved that the applicant is owner of the said vehicle. No fruitful purpose will be served by keeping the vehicle idle. The applicant undertakes to abide conditions which will imposed in the event his application is allowed. Therefore, I think it is proper to release the abovesaid vehicle on supratnama in favour of applicant imposing certain conditions. Hence, following order.

ORDER

- 1) The application is allowed.
- 2) The seized Splendor Pro Motorcycle bearing Registration no.MH-34 AF-2667 (Chassis no.MBLHA10AABHD04315 and Engine no.HA10EGBHD23767) be released on supratnama bond of Rs.50,000/-(Rupees Fifty Thousand) with one solvent surety of P.B. & S.B. of Rs.15,000/-.
- 3) Applicant shall not transfer, alienate and change the

nature of the vehicle till the conclusion of trial.

- 4) Applicant is directed to submit his identity card i.e. Addhar Card, before the Court while executing supratnama bond.
- 5) Applicant is directed to take photographs of the vehicle and submit it before this court.
- 6) The applicant shall produce above vehicle whenever it is directed by the Court.
- 7) The applicant shall not use the said vehicle in similar type of offence.
- 8) The Investigating Officer is directed to attach this order to the said Crime no.8/2021 which is pending in concerned Court.
- 9) Bond to be executed before this Court.
- 10) Humdast allowed.
