**ORDER BELOW EXH. 06**

(Passed on this 24th day of June, 2026)

1] By this application the applicant **Sandip Laxmanrao Mude** is seeking interim custody of the golden ornaments and DVR box of CCTV camera and wifi box. The ornaments i.e. one gold locket and Mangalsutra of 49.230 gm., one gold bracelet of 24.820 gm., one ladies gold kada of 10.430 gm., one gold bracelet of 5.760 gm., one gold chain of 8.850 gm., one pair of gold tops of 5.820 gm., one gold chain of 18.180 gm., one gold ring of 5.350 gm., one pair of gold tops of 3.640 gm., one pair of gold string (सोन्याचे वेल) of 4.510 gm., one gold ring of 3.560 gm., one gold Mangalsutra of 13.270 gm., one pair of gold tops of 930 mg., one pair of gold tops of 1.020 gm., one gold ring of 1.770 gm., one gold ring of 2.980 gm., one gold locket of 200 mg., (*hereinafter referred as 'ornaments'*) and DVR box of CCTV camera and wifi box, seized by Hinganghat Police in C.R.No. 37/2026 registered under Section Section 331(3), 331(4) and 305 of B.N.S..

2] It is averred that, the seized Gold ornaments and DVR box of CCTV camera and wifi box are of applicant. Seized muddemal are in custody of Police Station, Hinganghat. If it is kept at police station, it will be damaged. If it is not handed over it will cause loss to the applicant. Hence, prayed to allow the application.

3] Say of IO and learned APP is called for. The IO filed his say vide Exh.9 and submitted that the seized items were received from police station Nagpur. Item No.1 yellow metal locket, weighing 49.260 gm. and item No.11 yellow metal ear chain, weighing 4.510 gm. But in the certificate received from the goldsmith for both the said items, instead of the yellow metal locket, it is mentioned as a mangalsutra (with locket), whose combined weight is 49.260 gm, and instead of the yellow metal ear chain, it is mentioned as two pieces of string (needle thread) whose weight is 4.510 gm. All the items have been identified by the complainant. He further submitted that after the conditions that the applicant should not be disposed of in any way till the said case is decide and he will produced the seized muddemal to the IO if necessary, then he has no objection to released the seized muddemal. Ld. APP filed his say and submitted that the said seized property was seized by the police from the possession of the accused during the course of investigation, after lodging the FIR by the complainant/applicant. Therefore if this applicant is fully and properly satisfied then prayed to pass appropriate order.

4] Perused the documents produced by the applicant i.e. verified copy of Bills of ornaments and DVR box of CCTV camera and wifi box, adhar card of applicant, ration card and copy of FIR. It is the interim custody. Except applicant no one come forward to claim the said seized muddemal. The purchase bill produced by applicant goes to show that, he is the rightful claimant of the seized ornaments and DVR box of CCTV camera and wifi box. Hence, considering the submission of applicant, the court is of the opinion that, there is no

strong reason to reject the application in respect of said seized ornaments and and DVR box of CCTV camera and wifi box. The applicant is entitled for the interim custody of the ornaments and DVR box of CCTV camera and wifi box upon some conditions. Certain condition in that regard is imposed, it will suffice the purpose. Hence, the following order.

ORDER

- 1] Application is allowed.
- 2] Police Station officer, Hinganghat police station is directed to handover Golden ornaments i.e. one gold locket and Mangalsutra of 49.230 gm., one gold bracelet of 24.820 gm., one ladies gold kada of 10.430 gm., one gold bracelet of 5.760 gm., one gold chain of 8.850 gm., one pair of gold tops of 5.820 gm., one gold chain of 18.180 gm., one gold ring of 5.350 gm., one pair of gold tops of 3.640 gm., one pair of gold string (सोन्याचे वेल) of 4.510 gm., one gold ring of 3.560 gm., one gold Mangalsutra of 13.270 gm., one pair of gold tops of 930 mg., one pair of gold tops of 1.020 gm., one gold ring of 1.770 gm., one gold ring of 2.980 gm., one gold locket of 200 mg., and DVR box of CCTV camera and wifi box, to the applicant **Shri. Sandip Laxmanrao Mude** after executing indemnity bond of Rs. 5,00,000/- (Five Lakh Only).
- 3] The applicant is directed not to change the original nature of muddemal i.e. ornaments and DVR box of CCTV camera and wifi box and not to create third party interest either by way of sale, mortgage etc. till final disposal of the case.
- 4] The applicant is directed to produce the above mentioned Ornaments, DVR box of CCTV camera

and wifi box as and when directed by this Court.

- 5] I.O to prepare detail Panchnama and take photographs before handing over the same to applicant.
