**OFFENCE UNDER SECTIONS 303(2), 3(5) of the BHARTIYA NYAYA
SANHITA, 2023, SECTIONS 3(1)/181, 130, 177 OF THE MOTOR
VEHICLE ACT, SECTION 4/21 OF MINES & MINERALS (DEVELOPMENT

COMMITTAL ORDER

(Passed on 11th day of June, 2026)

The Police Station Officer, Pulgaon has filed the instant Charge-sheet in Crime No.43/2026. The accused are present before the Court. They have filed Purnis at Exh.19 stating that they will appear before the Hon'ble Sessions Court, Wardha. The offences registered against the accused is punishable under Sections 303(2), 3(5) of the Bhartiya Nyaya Sanhita, 2023, Section 181, 130, 177 of the Motor Vehicle Act, Section 4/21 of Mines and Minerals (Development and Regulations) Act, Section 3 of the Prevention of Damages to Property Act. The offence punishable under Section 4/21 of Mines and Minerals (Development and Regulations) Act is exclusively triable by the Hon'ble Court of Sessions.

2) The copies of police report and other documents as specified in Section 230 (or Section 231) of the Bhartiya Nagarik Surakha Sanhita

are supplied to the accused. The accused submitted that they have engaged their learned counsel Shri D.D.Lanjewar on their own expenses. As such, the case will have to be committed to the Hon'ble Court of Sessions. Hence, the following order

ORDER

- 1) The case is committed to the Hon'ble Court of Sessions, Wardha.
- 2) The accused are directed to appear before the Hon'ble Sessions Court, Wardha on 07/07/2026.
- 3) The Investigating Officer is hereby directed to produce muddemal before Hon'ble Court of Sessions, Wardha.
- 4) The record of case, documents, and articles which are to be produced in evidence, shall be sent to the Court of Sessions.
- 5) The Public Prosecutor be notified of the commitment of the case to The Hon'ble Court of Sessions.
