ORDER BELOW EXH NO. 17

This is an application filed by informant Rajesh Kalbande for compounding of offence p/u/s. 379 of Indian Penal Code as per section 320 of Cr.P.C.

2. The informant namely Rajesh Kalbande has stated and submitted that he had filed F.I.R. bearing no.178 of 2022 against accused punishable u/s.379 of I.P.C. Now, the matter is amicably settle between accused and informant. Hence, he want to compound this offence against accused.

3. On perusal of record and application, it is seen that evidence of informant and other two witnesses has recorded by prosecution. Now, informant want to compound this offence. As per section 320 of Cr.P.C. the offence p/u/s. 379 may be compounded by the owner of stolen property. As per the police report and evidence of informant, he is the owner of stolen property. Thus, as per section 320 of Cr.P.C. he is the authorized person to compound this offence against accused. Thus, when dispute is amicably settle between informant and accused then there is no hurdle to grant permission to compound this offence. Hence, considering aforesaid reason, I pass following order.

ORDER

1. Application is allowed.
2. Accused is acquitted from the offence p/u/s. 379 of I.P.C. vide section 320(8) of Cr.P.C.
3. P.B. and S.B of accused are cancelled.
4. Stolen property deposited at police station Karanja Gha. in property registered no.43/2022 shall be return to informant.
5. Case is disposed of as compounded.
