

Order below Exh.33

Non applicant filed present application under section 151 of Civil Procedure Code for modifying the order passed on 02.09.2025 in respect of depositing cost amount of Rs.4,000/- and thereby reduce the said amount.

2. It is submitted by learned advocate for the non applicant that on 02.09.2025 order passed in respect of depositing the cost amount of Rs.4,000/-at Exh.29. It is submitted that non applicant is 62 years old aged woman. His husband is passed away. She has multiple diseases like High B.P, Thyroid etc. She has no source of income. She somehow makes a living at the mercy of her daughter. Therefore, prayed that the order of depositing the amount of Rs.4,000/- passed on 02.09.2025 at Exh.20 be reduced.

3. Learned advocate for the applicants filed say on overleaf of the application. It is submitted that non applicant is going to prolong the matter. There is no any genuine financial difficulties. Even though there is no attempt about settlement between parties which can inference to reduce the cost. Hence, prayed for rejection of the application.

4. After going through the record it appears that Court passed on 13.11.2024 that non applicant appeared on 25/09/2023, since then no say filed, hence, application rejected. Than again on dtd.12/12/2024, the non-applicant has filed an application for time to

file reply, which was granted by the Court on same day. Thereafter again on dtd.16/01/2025 non-applicant has filed an application for time to file reply, which was also rejected by Court on 16/01/2025 and the application to set aside no say order is filed on dtd.13/02/2025 and that application was allowed by this Court on dtd.02.09.2025 subject to costs of Rs.4,000/- to pay to the applicant no.1. Thereafter, applicant filed this present application to reduce the costs. Considering the reasons mentioned in the application and say it is just and proper to reduce the cost from Rs.4,000/- to Rs.2,000/-. Hence, I pass the following order.

ORDER

1. Application is allowed.
2. Direction be given to non applicant to pay the cost of Rs.2,000/- to the applicant within 15 days from the date of order otherwise the matter will proceed 'no WS' against him.
