State Vs. Yash

ORDER BELOW EXH.07.

By this application, the applicant Sachin Namdev Ufade has prayed for return the Honda company makes vehicle bearing registration No.MH37-AE-1396 seized in crime No.198/2026 registered with Police Station Washim, Tq. Dist.Washim for the offences punishable under section 103(1) of BNS 2023 and section 3(2)(v) of Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989.

2] Investigating officer and learned APP filed say vide Exh.18 and prayed to pass necessary order.

3] Heard learned advocate for the applicant and learned APP for the prosecution.

4] As per the prosecution, the Honda company makes vehicle bearing registration No.MH37-AE-1396 is seized in the present crime. Applicant filed documents regarding the vehicle. Verified copy of R. C. book shows ownership of the applicant to the seized vehicle. The copy of insurance shows that the vehicle is insured till 16/09/2027 midnight. The vehicle may be required by the applicant for his day to day affairs. Keeping the vehicle idle in the police station will not serve any purpose. On the contrary, it may cause damage to the vehicle. The learned APP also has not objection to return the vehicle to the applicant. Therefore, I think that the vehicle needs to be returned to the applicant.

5] In the result, I pass following order.

ORDER

- 1] Application (Exh.07) is allowed.
- 2] On executing indemnity bond of Rs.1,00,000/-, (Rs. One lakh only) seized Honda company makes vehicle bearing registration No.MH37-AE-1396 be returned to applicant **Sachin Namdev Ufade** on the following conditions :-
 - i) Applicant should not alter, change, modify or damage the vehicle in any manner till the conclusion of trial nor should part with its possession nor should alienate it.
 - ii) Applicant should keep the vehicle comprehensively insured by the insurance policy, till the conclusion of trial.
 - iii) Investing Officer should take requisite photographs of the vehicle for its proper identification.
- 3] Hamdast allowed.
