

ORDER BELOW EXH.1

The matter is amicably settled between parties in mediation center. The following terms are agreed between the parties.

2. The respondent No.4 shall pay Rs.28,00,000/- (Rs. Twenty eight lakh only) towards compensation to the claimants including NFL, interest and costs within 60 days from the date of order. Failing which it shall pay interest @ Rs.9 % p.a. from today i.e. 13/02/2026 till its full realization.

3. The respondent No.4 shall pay the amount either through RTGS or NEFT in the bank account maintained by the Tribunal. The details of the bank account are as under :-

4. After deposit of the compensation amount in the above mentioned bank account, respondents shall inform the Tribunal by sending an e-mail.

5. Out of the total compensation amount, claimant No.1, is entitled to received the amount of Rs.9,33,334/- (Rs. Nine lakh thirty three thousand three hundred thirty four only) and out of said amount Rs.5,00,000/- (Rs. Five lakh only) be kept in fixed deposit in any nationalized bank for 5 years and amount of Rs.4,33,334/- (Rs. Four lakh thirty three thousand three hundred thirty four only) along with interest if any be paid to claimant No.1.

6. Out of the total compensation amount, claimant Nos.2 and 3 are entitled to received the amount of Rs.9,33,333/- (Rs. Nine lakh thirty three thousand three hundred thirty three only) each, and out of said amount of 5,00,000/- (Rs. Five lakh only) be kept in fixed deposit in any nationalized bank for 5 years and amount of Rs.4,33,333/- (Rs. Four lakh thirty three thousand three hundred

thirty three only) each along with interest if any be paid to the claimant Nos.2 and 3.

7. Amount coming to the share of claimants be credited in their bank account either through RTGS or NEFT.

8. The claimants shall produce copy of their savings bank account of any nationalized bank and their PAN Cards before receipt of the amount.

9. The matter shall be withdrawn against respondents.

10. Parties to bear their own costs.

11. Court fee be refunded as per rule.
