Devram Laxman Bhagat, the shares of the other plaintiff and defendant were increased as 1/6th shares. It is submitted that, previously, the plaintiff mentioned the shares of plaintiff and defendant as 1/7th shares in the suit properties but due to the death of Devrao Laxman Bhagat it is very necessary to amend the shares as 1/6th. It is submitted that, in Para No. 4, 6, 7 and prayer clause no. 1 the shares of suit property are mentioned as 1/7th shares and hence it is very necessary to amend the same in these Para No. 4, 6, 7 and prayer clause as 1/6th shares.

3] It is submitted that, the defendant no. 3 had filed M.J.C. Proceeding bearing no. 130/2024 for withdrawn the amount which is deposited by defendant no. 1 and 2 bearing C.C.D. 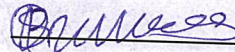
Hence considering the facts and circumstances of the matter, permission may kindly be granted to carryout the above stated amendment in the plaint in the interest of justice.
