ORDER BELOW EXH-61

Application below Exh.61 is moved by applicant for attachment of Pension of Non-applicant and for deduction of Rs. 10,000/- per month till satisfaction of this application.

02 As per contention of applicant, Non-applicant has taken voluntary retirement and despite of obtaining GPF and gratuity amount of Rs.14,00,000/- non-applicant has not paid any amount towards due maintenance of this applicant. Hence, prayed to deduct amount of Rs.10,000/- per month from pension of non-applicant.

03 On this application say of non-applicant and say of concern Drawing and disbursement authority has called. But non-applicant has not filed any say nor paid any amount towards due maintenance. The Drawing and disbursement authority has filed their say in which it is contended that, they are the authority which handover pension to the non-applicant. Said authority also filed pension slip of month of February-2026.

04 Heard applicant. Perused entire record. The non-applicant was directed to pay maintenance of Rs.4000/- per month to the applicant since the date of filing maintenance application. This application reveals that, an amount of Rs.2,48,000/- is due against non-applicant. This court through order below Exh.23 attached salary of non-applicant and passed order to deduct an amount of Rs.4000/- per

month from his salary and to sent deducted amount to this court till further orders in the name of applicant. Now as per contention of applicant non-applicant has accepted voluntary retirement and he has got pension in his name. On perusal of pension slip of non-applicant it appears that, non-applicant receives Rs.26,623 per month as a pension. Here, considering pension amount of non-applicant, maintenance amount of Rs.4000/- per month needs to be deducted from pension of non-applicant. Hence, following order:-

ORDER

1. Application below Exh.61 is partly allowed.
2. The Drawing and disbursement authority (Account Officer) of non-applicant Bharat Nivrutti Kamble is hereby directed to deduct an amount of Rs.4,000/-(Four thousand) per month from his pension.
3. The deducted amount of Rs.4,000/-(Four thousand) per month be sent to this Court every month in the name of applicant Kavita Bharat Kamble without fail till further orders.
