**ORDER BELOW EXH 1**

1] The present application is filed U/s 175(3) of the Bharatiya Nagrik Suraksha Sanhita, 2023. (Hereinafter referred to as the '**BNSS.**') to direct the concerned Police Station to register the offence against the proposed accused no.1 to 5. P.S.O has filed his submission at Exh.6. Heard Shri. R. G. Mang (Patil), learned advocate for the applicant. Perused the record and documents.

2] In short it is the contention of the applicant that, accused No. 2 to 5 are the relatives of accused No.1. The applicant and accused No.1 had loved affair. Therefore, her father forcefully asked her to file a case against the complainant. Accordingly, Crime No.204/2025 falsely registered against him for the offence punishable U/s. 137(2), 64(1) and 351(2)(3). On 01/09/2025 the applicant alongwith his uncle and brother came to see Ganpati orcherstra. At about 10:30 pm he was alone going on his vehicle after orchestra. At that time accused No.1 to 5 suddenly came and they started beating him with intent to kill him. Accused No.1 and 2 caused hurt over his neck and chest by knife. Accused No.3 to 5 also caused hurt to him by kicks and blows. They further abused him filthy language and threatened him with an injury to his life.

3] It is the further contention of the applicant that thereafter his brother and uncle and also other persons came there to separate a quarrel. At that time accused fled away. The applicant was badly injured. He directly went to P. S., Manora to file a report. The police referred him for medical

examination. Accordingly, MLC No.237 also prepared. However, the police declined to register his case. On 02/09/2025 under influence of the accused the police registered only NCR No. 908/2025. The role of the police is suspicious. Therefore, on 08/09/2025 he sent written complaint to Dy.S.P. Karanja. On 09/09/2025 he further sent a written report to S.P. Washim. However, the police concerned did not take action. Therefore, he was constrained to file present application.

4] PSO filed say at Exh.6 and submitted that already Crime No.204/2025 supra is pending against the applicant before Hon'ble Sessions Court and with ill-intent to harass, he has filed a present case. There is further another Crime No.139/2025 is registered with PS. Darvha, Dist.Yavatmal against the present applicant.

5] Learned Advocate Shri. R. G. Mang (Patil) has brought to notice of Court a NCR at Police Station Manora dated 02/09/2025 and written report dated 08/09/2025 and 09/09/2025 sent to Dy.SP, Karnja and S.P. Washim and receipt thereon. He has also sent a copy to S.P. Washim. The applicant has further filed affidavit in support of his contention. He has also filed documents such as the copy of N.C.R and reports. The material on record prima-facie supports the contentions of the applicant.

6] It appears from the record that, already complainant has approached to the concerned Police Station under section 173 of the BNSS. The offense alleged under Section 296, 115(2), 118(1), 352, 351(2)(3) r/w 3(5) of the BNS is cognizable in nature. The complainant has prima-facie made out the ingredients under supra sections of the BNS against accused No.1 to 5. Hence, considering the facts and circumstances of the case, I pass the following order.

ORDER

1. Police Inspector, Police Station Manora, Tq.Manora Dist.Washim is hereby directed to register the crime under Section 296, 115(2), 118(1), 352, 351(2)(3) r/w 3(5) of the BNS against accused no.1 to 5 and investigate into the matter in accordance with the present complaint and report accordingly.
2. True copy or certified copy of the application alongwith the order passed by this court shall be sent to the concerned police station.
3. Letter be issued accordingly.
