ORDER BELOW EXH.1

(Passed on 23.04.2026)

This is an application for grant of legal heir certificate under Section 2 of the Bombay Regulation Act, 1827. Heard Ld. Adv. Shri. M. S. Ingole for the applicants. Perused the record.

2] It is the contention of the applicants that the applicants no. 1 to 4 are the grandsons and daughter of the deceased namely **Sonaji Baliram Pawar**. Sonaji died on 02/01/21975. Thereafter, only son of the Sonaji namely Kaluram Sonaji Pawar who is the father of the applicants also died on 01/01/2001 and the mother of the applicants namely Anusaya also died on 31/12/2009. It is further contention of the applicants that except them there are no other legal heirs of the deceased Sonai. They are in need of legal heirs certificate for some official purpose.

3] Paper publication and citation notice was issued inviting all persons, who disputes the rights of applicants to appear in Court and to enter their objection. Despite the fact none appeared before the Court for taking objection.

4] The applicants have examined applicant no.1 vide affidavit at Exh.9. He has also filed documents such as the death certificate of the deceased **Sonaji, Kaluram, Anusaya** at Exh.10 to 12, heir-ship certificate at Exh.13, Adhar Cards at Exh.14 to 17, paper publication is at Exh.18, Citation notice is at Exh.6. Further applicant filed pursis at Exh.19.

5] After paper publication and citation notice none appeared before the Court for taking objection. From the affidavits and documents filed by the applicant, it can be concluded that, the applicants no.1 to 4 are the legal heirs of the deceased namely Sonaji. Considering the relationship of the applicants with deceased namely Sonaji as shown in application and evidence produced on record, heir-ship certificate is required to be issued in favour of the applicants no.1 to 4. In result, I pass the following order.

ORDER

- 1] Application is allowed.
 - 2] Issue heir-ship Certificate in favour of the applicant No.1 **Parashram Kaluram Pawar**, applicant No.2 **Ashok Kaluram Pawar**, applicant No.3 **Vimal Gangaram Chavhan** and applicant no.4 **Kamala Natthu Solanke** in the prescribed format (Appendix B).
 - 3] Applicants to submit court fees stamp as per rules.
