ORDER PASSED BELOW EXH.01.

1. The applicants have claimed Legal heirship certificate under Section 2 of the Bombay Regulation Act, on the ground of legal heirs of deceased Hirasing Madhusinh Raghuwanshi.

2. It is the contention of the applicants that, Hirasing Madhusinh Raghuwanshi was died on 10/12/1994 at Mangrulpir, Tq. Mangrulpir, Dist. Washim. Applicant No.1 is the widow, applicant Nos.2 to 4 are sons and applicant Nos.5 & 6 are daughters of deceased Hirasing Madhusinh Raghuwanshi. The applicants are the only surviving legal heirs of deceased Hirasing Madhusinh Raghuwanshi. Applicants are in need of legal heirship certificate in their favor.

3. In pursuance to the application, citation notice Exh.06 as well as paper publication in daily "Punyanagari" newspaper dated 11-04-2026 vide Exh.12 was issued and thereby objections were called. But, none was appeared and objected the claim of applicants as legal heirs of deceased Hirasing Madhusinh Raghuwanshi.

4. Applicant no.1 Shaila Hirasingh Raghuwanshi adduced her evidence by way of affidavit vide Exh.09. So also filed documents i.e. death certificate of deceased Hirasing Madhusinh Raghuwanshi at Exh.10, the heirship report issued by the President of Municipal Council Mangrulpir, Tq. Mangrulpir Dist. Washim at Exh.11 in support of their claim. Applicants closed their evidence by filing pursis at Exh.13. The Applicant's evidence remained unchallenged as none appeared to oppose.

5. The contentions stated on affidavit are unchallenged. Therefore, there is no reason to disbelieve the same. From the

documents produced on record as referred supra it is formally established that the applicants are the legal heirs of deceased Hirasing Madhusinh Raghuwanshi. Therefore, I am inclined formally to hold that the applicants are the legal heirs of deceased Hirasing Madhusinh Raghuwanshi. Hence, I proceed to pass following order.

ORDER

1. The application is allowed.
2. Issue heirship certificate in the name of applicants, after payment of necessary Court fee, if any, stating therein that, the applicants are the surviving legal heirs of the deceased Hirasing Madhusinh Raghuwanshi.
3. Applicants are directed to furnish necessary Court fee stamps in terms of provisions of Bombay Court Fees Act, 1870, within 30 days from this order.
4. On compliance of necessary formalities in this order a heirship certificate in terms of schedule B of the Bombay Regulation 1827 shall be given to applicants.
5. Present application is accordingly disposed off for the compliance by the applicants.
