ORDER PASSED BELOW EXH.1.

(Passed on 14th August, 2026)

Today Shri. Brijmohan Shyamsundar Malpani, who is current President of Panjarpol Sanstha, Karanja (Lad) i.e. plaintiff No.1 is present along with his learned advocate Shri. D. K. Pinjarkar. Moreover, Shri. Prakash Madhukar Sawalkar, who is current President of Adarsha Shikshan Sanstha, Wai i.e. defendant No.1 is also present along with his learned advocate Shri. N. S. Patil. Learned advocates on behalf of both parties to the suit have submitted that the matter is amicably settled between the parties to the suit out of the Court in view of terms and conditions as set out in mutual compromise memo at **Exh.43**. It appears that parties to the present suit have filed said joint mutual compromise memo at **Exh.43** thereby praying for passing mutual compromise decree as dispute is amicably settled between them in view of terms and conditions as mentioned in said memo. The contents of said compromise memo have been read over and explained to the parties who are present and they have admitted the same to be correct. As such, the parties to the suit have prayed for disposing of present suit by passing mutual compromise decree. Said compromise memo bears signatures of the President of plaintiff No.1 and the President of defendant No.1 along with signatures of their respective learned advocates. In view of compromise memo at **Exh.43**, following order is passed.

ORDER

- 1] Present Suit is disposed of as withdrawn and settled in view of terms and conditions as set out in mutual compromise memo at **Exh.43**.

- 2] Mutual compromise decree be drawn up in view of terms and conditions as set out in compromise memo at **Exh.43** accordingly.
- 3] Compromise memo at **Exh.43** shall form part and parcel of record.
- 4] Court fee be refunded to plaintiffs as per rules.
- 5] Proceedings of present suit is closed.
