JUDGMENT

(Delivered on 22nd September 2021)

Accused Madanlal Narayanlal Parihar is present in person before the Court. I have given him understanding and the consequences of admitting the guilt. He has admitted the guilt. He prayed that minimum fine be imposed. Taking into consideration, the nature of offence, I proceed to pass the following order :-

ORDER

1) Accused Madanlal Narayanlal Parihar is convicted for the offence u/s. 6 (B) P/U/S. 24 of Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, supply and Distribution) Act, 2003 vide section 252 of the Code of Criminal Procedure.

2] The accused is sentenced to pay fine of Rs.200/- (Two Hundred Rupees only) for the offence under section 6 (B) P/U/S. 24 of Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, supply and Distribution) Act, 2003 in default to suffer simple imprisonment for Seven days.
