J U D G M E N T

(Delivered on 12.11.2022)

Accused voluntarily plead guilty. I made him/them aware about the nature and punishment of offence and consequences of pleading guilty. I verified that the plea was voluntary. Considering the nature of offence and the punishment prescribed for the same I accept the plea of accused.

Heard the accused and learned APP on the point of sentence. Accused has submitted that it is his first offence, They are sole earning member of his family. Family members are dependents on them. Hence punishment after G.A. for abatement of gambling will be same as per sections 4, 5 of G.A. Therefore lenient view may kindly be taken into account while awarding the sentence. In the result, I pass the following order.

O R D E R

1) Accused are convicted u/s. 252 of the Code of Criminal Procedure, 1973 of the offence punishable under **section 4, 5 of Prevention of Bombay Gambling Act** and sentenced to pay a **fine Rs. 300/- each (Rs. Three Hundred only)** in default to suffer imprisonment of one day and is sentence till rising of court

2) The bail bonds of accused is canceled.

3) After appeal period is over :-

a) cash be credited to State.

b) Seized instruments of gambling being worthless be destroyed after appeal period is over.

c) Seized muddemal if any be disposed of as per law.
