ORDER BELOW EXH. 01

(Passed on this 02nd day of May, 2026)

1. This is an application for grant of heirship certificate under Section 2 and 3 of Bombay Regulation Act 1827.

2. The case of applicant is that the the applicant Smt. Durga Ramkisan @ Kisan Pande is the daughter of deceased Sahadev Tukaram Sahare who died on 28/08/2003. The deceased Sahadev Tukaram Sahare was having Sudhakar Sahadev Sahare, Madhukar Sahadev Sahare and Arvind Sahadev Sahare as three sons and the applicant is the daughter. All the three sons are died. Sudhakar Sahadev Sahare was died on 31/05/2008, Madhukar Sahadev Sahare was died on 29/05/2007 & Arvind Sahadev Sahare was died on 21/09/2011. It is contended that, all the three sons were unmarried. It is further contended that, Shantabai was the

mother of the applicant who also died on 05/08/2024. It is contended that applicants want to get mutated their name in 7/12 Extract of Gat No. 223/3, and for other official formalities and general acknowledgment heirship Certificate is very much needed. Hence, this application.

3. In support of application, applicant Smt. Durga Ramkisan @ Kisan Pande has filed an affidavit vide Exh. 11 and also filed the following document in support of his contention i.e. copy of death certificate of deceased Sahadev Tukaram Sahare, marked at Exh.12, copy of death certificate of deceased Shantabai Sahadev Sahare, marked at Exh.13, copy of death certificate of deceased Sudhakar Sahadev Sahare, marked at Exh.14, copy of death certificate of deceased Madhukar Sahadev Sahare, marked at Exh.15, copy of death certificate of deceased Arvind Sahadev Sahare, marked at Exh.16, copy of family details issued by G.P. Mohada, marked at Exh.17, copy of 7/12 extract of agricultural field Gat No. 223/3 and Gav Namuna 8-A, marked at Exh. 18 & 19 respectively, verified copy of Adhar Card of the applicant at Exh. 20, verified copy of School Leaving certificate marked at Exh. 21, copy of news paper (Dainik Matrubhumi) and its

receipt at Exh. 22 & 23 respectively. Proclamation is circulated in locality and also published in daily newspaper 'Dainik Matrubhumi' but no objection received.

4. Relying on the affidavit and documents filed on record by the applicant, it can be stated that the applicant is the legal heir of deceased Shantabai Sahadev Sahare. The legal heirship certificate be granted in the name of applicant only and therefore heirship certificate under Section 2 of Bombay Regulation Act 1827 may be issued in his name only. Hence, following order:-

ORDER

1. Application is allowed.
2. Issue Heirship Certificate in prescribed form in the name of applicant as she is the only legal heir of deceased Shantabai Sahadev Sahare.
3. Proceeding stands disposed off.
