## **ORDER BELOW EXHIBIT-1**

(Passed on: 16.03.2026)

This is an application filed by the applicants for issuance of legal heirship certificate under section 2 (8) of the Bombay Regulation Act, 1827.

2. Deceased Shri. Prakash Sambharao Tambade was husband of applicant no. 1 and father of applicant no. 2 to 5. Shri. Prakash Sambharao Tambade died on 04.12.2020. Leaving behind his the applicants as their legal heirs except the applicants, there is no other legal heir of deceased Shri. Prakash Sambharao Tambade. Deceased Shri. Prakash Sambharao Tambade did not execute any will during their life-time. Applicants require heirship certificate for filing the same in various Government offices. Hence, the application.

3. Applicant no. 1 & 2 are examined themselves on affidavit (Exh. 10 & 11) respectively and reiterated all the facts stated in the application. Applicants filed death certificate of deceased Shri. Prakash Sambharao Tambade at (Exh. 13), Verified copies of Adhar card of applicants along with list of document at (Exh. 03) and paper proclamation at (Exh. 9). Applicants have closed the evidence vide pursis (Exh.12).

4. A public notice was published in daily news paper "Dainik Lokdut" on 21.01.2026 and thereby objections, if any, were called from the public at large. However, no any objection is received against the claim of applicant for issuance of legal heirship certificate.

A paper proclamation published in the said newspaper is filed at (Exh.9). The claim of applicant has gone unchallenged on record.

5. The applicant is seeking heirship certificate of deceased Shri. Prakash Sambharao Tambade for legal recognition. From record, it is clear that, deceased Shri. Prakash Sambharao Tambade was died living behind applicant as his legal heirs. Hence, the applicant no 1 to 5 are the only recognized legal heirs of deceased Shri. Prakash Sambharao Tambade and they are not entitled for benefit on the basis of said legal heirship certificate without following due process of law. Hence, I pass following order-

**ORDER**

1. Application is allowed.
2. Issue heirship certificate in the name of applicants as recognized legal heir of deceased Shri. Prakash Sambharao Tambade on payment of necessary Court fees stamp.
3. The applicants shall not claim any other benefits or any relief including monetary relief, on the basis of said legal heirship certificate issued to them without following due process of law.
