- 1) Accused No. 1 **Pravin Vijaylal Jaiswal** is convicted u/s. 275 of the Bhartiya Nagarik Suraksha Sanhita, 2023 of the offence punishable under section 4,5 of The Maharashtra Prevention of Gambling Act and sentenced to pay a fine Rs.100/-(Rs. One Hundred only) in default to suffer imprisonment of one day.
- 2) The bail bonds of accused No.1 are canceled.
