**ORDER PASSED BELOW EXH.01**

1) Today the case is listed for committal order. Accused no.3 appeared today in pursuance of summons. Accused no.1, 2, 4 & 5 are in Jail. In pursuance of production warrant, accused no.1, 2, 4 & 5 have been produced before this court through Video Conferencing at 3.45 pm by Yavatmal Jail Authority. Accused persons are represented by Advocate Shri A.M.Tapase and for accused no.3 Shri.Shaikh.

2) Accused persons are charge-sheeted with the offense punishable under **Section 331(6), 309(6), 310(2), 62(2)(a) & 238 of BNS, 2023**. That, offence punishable under **Section 310(2)** is exclusively triable by the Hon'ble Court of Sessions.

Hence, the case is committed to the Court of Sessions. Accused persons have been informed about the same. Accused persons acknowledged the same. Copies of police report and other documents as specified in **Section 230 of BNSS, 2023** have been supplied to the accused persons. Accused persons filed the Pursis and acknowledged the same. Hence following order.

**ORDER**

1. The case is committed to the **Hon'ble Court of Sessions, Kelapur.**
2. Warrant of commitment as per Form no.III provided in Chapter XXXIII of Criminal Manual is issued to the Superintendent, Yavatmal Jail, Yavatmal to keep the accused no.1, 2, 4 & 5 in his custody until they receives the order of Hon'ble Court of Sessions, Kelapur to produce them.
3. The record of the case, the documents and articles which are to be produced in evidence shall be sent to the Hon'ble Court of Sessions on or before **02/04/2026.**
4. The Police Station Officer, Wani Police Station be directed to produce Muddemal property if any, in the Hon'ble Court of Session, Kelapur on or before **02/04/2026** positively.
5. The Public Prosecutor, Kelapur shall be notified regarding commitment of the case to the Hon'ble Court of Sessions vide Form no. 31, Schedule II of Cr.P.C.
