STATEMENT OF ACCUSED U/SEC. 313 Cr.PC.

Q1: Have you heard the evidence of prosecution witnesses?

Ans:

Q2: PW-1 Arunkumar H L, PW-3 Krishna K C, PW-4 Ravi H S, PW-6 Girishkumar K T have deposed that, by hearing the death of deceased Mani they have gone to the linehouse of deceased and saw the deadbody of deceased Mani and blood was lying. What do you say?

Ans:

Q3: PW-14 Thammaiah has deposed that, deceased Mani was residing in the linehouse of Accused and after death of deceased Mani, he has gone to the linehouse and deadbody was lying in the blood and he has sustained injury in the left side of the head and his head was near door frame of linehouse. What do you say?

Ans:

- Q4: PW-4 Ravi H S and PW-18 Kyathegowda, CPI have deposed that, PW-18 has issued notice to panch witnesses, as per Ex.P6 and PW-18 has conducted inquest mahazar of deceased Mani in front of linehouse and he has signed to the mahazar. What do you say?

Ans:

- Q5: PW-9 Jagadeesh M B and PW-18 have deposed that, on 14.12.2017, PW-18 has called PW-9 and another to the Cemetery situated at Kushalnagara Market road and PW-9 dig a pitch and buried the deadbody of deceased Mani and they have signed to mahazar, Ex.P11. What do you say?

Ans:

- Q6: PW-15 Rehman and PW-18 have further deposed that, on 13.12.2017 PC-308 has produced MO No.8 to 11 Clothes on the deadbody and PW-18 has seized the same under mahazar, as per Ex.P8. What do you say?

Ans:

- Q7: PW-10 Swamy Nayak, PDO has deposed that, as per the requisition given by police, he has issued Residential certificate of Accused Subramani, as per Ex.P13. What do you say?

Ans:

- Q8: PW-11 Dr. Chandrashekar has deposed that, police have sent 11 sealed articles and he has opened the same and examined and found bloodstained on article No.1, 3, 5 and 6 to 11 and the said blood was A' Group blood belongs to human and issued FSL report, as per Ex.P14. What do you say?

Ans:

- Q9: PW-12 Dr. Harish has deposed that, on 13.12.2017, he has conducted PM examination of deadbody of one Mani and found external injuries and took specimen of internal organs and sent for FSL examination and issued PM report, as per Ex.P17. What do you say?

Ans:

- Q10: PW-12 has further deposed that, on 05.03.2018, he has received FSL report and given opinion that, the cause of death is due to hamorrhagic shock from bleeding and leading to cardio-pulmonary arrest, as per Ex.P17. What do you say?

Ans:

- Q11: PW-12 has further deposed that, if anybody smashes the head of the person to the frame of door, such injuries may be caused, due to heavy bleeding and he has also issued clarification in respect of opinion, as per Ex.P19. What do you say?

Ans:

- Q12: PW-13 Dr. Padmaja Kulkarni has deposed that, she has received 2 articles to her Pathology department and she has opened the same and examined microscopy examination and given findings, as per Ex.P18. What do you say?

Ans:

- Q13: PW-16 Prashanth DSouza has deposed that, police have given memory card of Sony company digital camera and he has put the same to computer and converted into DVD and given to police and further took prints of 46 copies of photos and 3 copies of photos and issued Attestation certificate. What do you say?

Ans:

Q14: PW-17 Mahesh J E, PSI had deposed that, on 13.12.2017 at about 1 pm, he has received complaint from the Accused and registered the same under his PS crime No.169/17 and sent FIR to the court and handed investigation to CW-1. What do you say?

Ans:

Q15: PW-18 has further deposed that, at the time of inquest mahazar, he has recorded statements of CW-10 and 11 and seized MO No.1 to 7 from the spot and submitted seized properties under PF No.132/17 and taken photos of the spot. What do you say?

Ans:

Q16: PW-18 has further deposed that, he has recorded statements of CW-2 to 5 and 21 and submitted seized properties under PF No.172/17 and received samples sent by doctor and submitted same under PF No.134/17 and 135/17 and taken the print of photos through CW-23 and received Attestation certificate and CD. What do you say?

Ans:

Q17: PW-18 has further deposed that, he has received RFSL report and sent the same and obtained Final opinion of the doctor about cause of death. What do you say?

Ans:

Q18: PW-18 has further deposed that, he has suspected on the Accused and enquired the Accused in front of CW-3 and 4 and recorded confession of statement of Accused and submitted self complaint and recorded supplementary statements of CW-3 and 4 and arrested Accused and produced before Court. What do you say?

Q19: PW-18 has further deposed that, he has received another opinion of the doctor and filed charge sheet against the Accused. What do you say?
