ORDER PASSED BELOW EXH.15 IN

O.M.C.A.No.133/2024.

*Kundeshwari @ Prerana Vikas Kinhekar & Ors .Vs. Vikas  
Kamlakar Kinhekar*

1. The applicants filed present application for attachment of salary of the non-applicant. The non-applicant failed to appeared and filed his reply. Hence, the application is proceeded without reply of the non applicant.
2. Perused the application. The applicants contended that, the non-applicant has not paid the maintenance amount. The non-applicant is serving in Central Reserve Police Force. An amount of more than 6 lakhs is outstanding against the non applicant. Therefore, they prayed to attach salary of the non-applicant towards maintenance amount.
3. Heard the Ld. Advocate of the applicant. He submitted as per the contentions of application. Perused the record and proceeding. It appears that, in Cri M.A.No.41/2020, vide order passed below Exh.15 dtd.19/10/2022, an interim maintenance amount of Rs.10,000/- is granted to both the applicants. The non-applicant has not paid single penny. It appears that, the non-applicant is willfully disobedience the said order. Moreover, he has not appeared before the court in spite of the due service of notice.
4. The record shows that, the non-applicant is serving in Central Reserve Police Force. He is getting handsome salary. The applicants filed salary slips of the non-applicant for the month of July

2023 and November 2023. The non-applicant gets net salary near about of Rs.50,000/-. The record shows that, an amount of Rs.4,40,000/- is due towards the non applicant. The non-applicant is under obligation to pay the said amount to the applicants. Therefore, considering the due maintenance amount and salary of the non-applicant, it is lawful to attach a salary in the tune of an amount of Rs.20,000/- per month towards payment of maintenance. Thus, considering the above circumstances, I pass the following order,

**ORDER.**

1. The application is allowed.
2. The Drawing and Disbursement Officer, Directorate General Central Reserve Force, Block No.1 CGO Complex, Lodhi Road, New Delhi, (Force No.145252551, Unit/Office 089-BN) of the non applicant is directed to deduct an amount of **Rs.20,000/- (Rupees Twenty Thousand only)** per month from the salary of the non applicant namely Vikas Kamlakar Kinhekar and remit the same to this Court, in the name of Jt. Civil Judge (Jr.Dn.) and J.M.F.C., Wani, regularly, till further order.
3. The concern criminal clerk is directed to make the correspondence for implementing this order.
4. The application is disposed of, accordingly.
