JUDGMENT

1. The above named accused person stands trial for committing the offence punishable under Section 47(a) Excise Act.
2. Complainant case as per the complaint alleging therein that on 01.02.2016 at 7:10 pm a raid was conducted and 420 ltrs of illicit country made liquor was recovered from the house of accused Vikrant Prasad.
3. On the basis of the said complaint seizure was made and the instant case was registered against the accused for the offence u/s 47(a) Excise Act.

4. On 23.11.2021 charge was framed against the said accused for the offences u/s 47(a) Excise Act and the contents of charge explained to him in Hindi to which he pleaded not guilty and claimed to be tried.

5. On 19.01.2026 statement of the aforesaid accused person u/s 313 Cr.P.C. was recorded in which he pleaded himself to be innocent.

6. Point for determination in this case is as to whether the complainant could prove its case against the accused person, for charge levelled against him, beyond reasonable doubt or not ?

FINDINGS

7. Perused the entire case record, it transpires that after giving sufficient opportunities complainant had not examined any witness. Thus, it appears despite giving sufficient opportunities complainant has failed to produce any witness. Hence, it has become case of no evidence and accused person namely, **Vikrant Prasad** is held not guilty for the charges levelled against him u/s 47(a) Excise Act, accordingly, and he is acquitted due to lack of evidence. He and his sureties are also discharged from the liabilities of their respective bail bonds.
