FINAL ORDER

- (1) The present claim petition is here by disposed off by way of compromise.
- (2) The Insurance Company is directed to deposit **Rs.2,50,000/- (Rupees Two Lacs Fifty Thousand)** as per the settlement arrived between the parties.
- (3) Full amount shall be paid by way of **"RTGS/NEFT"** to the claimant, after due verification.
- (4) The amount of interim compensation, if any paid, be deducted from the final amount of the award.
- (5) The office is hereby directed that **medical expenses** of **Rs.30,000/- (Rupees Thirty Thousand only)** be paid to the claimant by way of **"Account Payee Cheque/RTGS/NEFT"** from the total amount of share payable to the claimant, after due verification.
- (6) It is hereby further ordered that 100% Court fees refund certificate be issued to the claimant accordingly, if any.
- (7) Since this matter is settled in the National Lok-Adalat, the deficit court fees is not required to be deducted as per Section 21 of Legal Service Authority Act.
