**ORDER**

- 1] Accused are convicted for the offence punishable Under Section 7 R/w 20 of Cigarettes and Other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003 and sentenced to pay fine of **Rs. 300/-** (Rupees Three Hundred Only) **each** in default to suffer simple imprisonment for **2** days.
- 2] The seized muddemal i.e. 40 packets of Hukka scented and Cigarette packets be sent to Food and Drugs Department, Pune for disposal accordingly to law, after appeal period is over.
