ORDER

1. Present application has been filed by applicant Kulwinder Singh for releasing him on interim bail for 15 days or in alternative for directing the Superintendent, Modern Jail, Faridkot for taking him in custody to village Burj Mohammad Shah, P S Makhu, District Ferozepur for attending bhog/antim ardaas of his father on 8-11-2019.

2. It is mentioned in the application that on 30-10-2019 Ujjagar Singh father of the applicant/accused had expired and his bhog/antim

ardaas is to be performed in village Burj Mohammad Sham, P S Makhu District Ferozepur on 8-11-2019 from 11-00am to 3-00pm. Further submits that the presence of the applicant/accused is very much essential at that time. The application is supported by Panchyatnama of the village.

3. Report from Police Station Makhu has been called. As per report of the concerned SHO, Ujjagar Singh son of Santa Singh resident of village Fatehgarh Panjtoor, Burj Mohamad had died on 30-10-2019 and his bhog ceremony is to be performed at village Burj Mohammad Sham, Police Station Makhu on 8-11-2019. The report is accompanied by panchyatnama as well as statements of Gursewak Singh Nambardar and Sukhdev Singh Member Panchyat of village Burj Mohamad Shan.

4 Heard. Ujjagar Singh, who was father of accused Kulwinder Singh had expired on 30-10-2019 and his bhog ceremony is to be performed on 8-11-2019 at village Burj Mohammad Shah, Police Station Makhu. The presence of the accused being the son of Ujjagar Singh is necessary at that time. Keeping in view the facts and circumstances mentioned in the application, no ground is made out to grant interim bail to the accused-applicant for 15 days. However, in the interest of justice, the present application is partly allowed and applicant Kulwinder Singh

is allowed to attend the bhog ceremony of his father which is to be performed at village Burj Mohammad Shah, Police Station Makhu on 8-11-2019 in custody from 11-00am to 4-00pm. The Superintendent, Modern Jail, Faridkot is directed to make necessary arrangements to send accused/applicant Kulwinder Singh in custody to village Burj Mohammad Shah, Police Station Makhu, District Ferozepur subject to deposit of the necessary expenses by the applicant-accused. SSP, Faridkot is directed to provide necessary security to the Superintendent, Modern Jail, Faridkot. Ahlmad is directed to send the copy of this order to Superintendent, Modern Jai, Faridkot. Application disposed off accordingly. Papers be attached with the main file.
