ORDER:

1. File put up today before me being Judge on Duty as per latest order of Ld.Sessions Judge, Amritsar, dated 31.5.2020, to deal with urgent criminal matters, in compliance of order dated 8.5.2020 and 23.5.2020 of Hon'ble Punjab & Haryana High Court, Chandigarh, due to outbreak of Novel Coronavirus(COVID-19).
2. This order of mine shall dispose of Ist bail application u/s.438 of Cr.P.C filed by applicant-accused for grant of anticipatory bail.

3. The applicant/accused has filed the present bail application with the averments that applicant is innocent and has falsely been implicated in this case. No offence has been committed by him and allegations against the applicant are vague in nature. Applicant is ready to join the investigation. Hence, this application.

4. Upon notice issued to State, Addl.PP for the State has appeared. Inspector Parminder Singh has come present alongwith police record.

5. I have heard ld.counsel for the applicant and Addl.PP for the State [through video conference](#) and gone through the file very carefully.

6. Perusal of the file shows that FIR in this case was registered on the basis of secret information that Gurdev Singh son of Harbhajan Singh r/o Village Bohru and his father is having a karyan shop in the village. He has kept a coloured printer. There is a curfew and lock down imposed by the Government due to Pandemic Covid-19, but after taking money from the people, especially migrant labourers, he is issuing them fake curfew passes. Said Gurdev Singh has taken illegal connection from the electric pole in the Bangla Basti, for making fake curfew passes and if raid be conducted, he can be

apprehended. Thereafter raid was conducted. Applicant could not be arrested. The counsel for the applicant has submitted that he has been falsely implicated in this case. Allegations against the applicant are very serious in nature that he is making fake curfew passes and giving them to the innocent migrant labourers, for moving one place to other. When raid was conducted, from the place mentioned in the FIR, colour printer make Epson has been recovered alongwith fake pass in the name of Jarnail Singh. Apart from this, one stamp of Sub Divisional Magistrate, Amritsar, has also been recovered. Thus allegations against accused are very serious in nature. He is cheating innocent people by giving them fake passes and extracting money from them. So custodial interrogation of the applicant is necessary in this case. As such present bail application of accused-applicant is dismissed. Police record be returned forthwith. Bail application file be consigned to record room.
