Ld. APP put his appearance on behalf of State but no reply has been filed by the State.

The contentions of the counsel for the accused/applicant is that accused/applicant is innocent and law abiding citizen. It is further stated that he has been falsely implicated in the present case and he is in custody. The Ld. counsel for the applicant/accused further argued that accused/applicant has not committed any offence.

Learned APP for the State submitted that accused/applicant is not entitled to concession of bail as the allegations levelled against the accused is serious in nature. So, prayed to dismiss the bail application of accused-applicant.

I have heard the learned counsel for applicant/accused and learned APP for the State and perused the file. The applicant/accused is in custody. No useful purpose shall be served by keeping the accused confined in the judicial custody for further long period as it would also be a burden on State Exchequer. Furthermore, no useful purpose is going to serve by keeping the applicant/accused behind the Bars as completion of trial will take time.

Therefore, the present bail application moved by the applicant/accused is hereby allowed, subject to furnishing of the bail bonds to the tune of Rs. 30,000/- with one surety in the like amount.
