12. That the applicant craves leave to add, amend or alter the bail application or grounds mentioned therein.

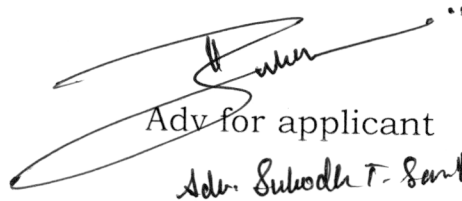
In the circumstances the application therefore pray:
