This petition filed on behalf of the petitioner to release him on bail u/s.483  
of BNS.

This petition is coming on this day for final hearing before this Court in the  
presence of **Tvl. N. Priyadharshini and R.K. Krithika**, Advocates for the  
Petitioner / Accused and **Thiru. V. Ravichandran, Public Prosecutor**, represented  
for State, upon perusing the petition submitted and upon hearing both side  
arguments, this Court pronounced the following:-

**ORDER**

**Heard both side.**

The petitioner is the accused in Crime No.45/2026 of Chettipalayam Police  
Station, for the alleged offence u/s.67A of IT Act r/w 75(1)(iii) of BNS @ 67A of  
IT Act, 75(2) of BNS, he has filed this petition, seeking grant of bail.

2. Previous bail petition filed by the petitioner in C.M.P.No.646/2026 was  
dismissed by this Court on 23-02-2026 and this is the second bail petition.

3. The learned counsel for the petitioner has submitted that the petitioner  
was arrested and remanded to the judicial custody on 04-02-2026. The alleged

Instagram ID is fake one and it was not created and managed by the petitioner herein. The petitioner herein is a college student. He met with an accident and his leg was fractured at this point, the respondent police arrested him and he has to take further treatment and he has got permanent resident and he will not abscond and he is ready to abide any conditions imposed by this Court and he is in prison for the past 36 days and prays to enlarge the petitioner on bail.

4. Opposing to grant bail to the petitioner, the learned Public Prosecutor has submitted that, the defacto complainant is the hostel warden of a college. The petitioner herein is studying in the said college. In this case, from the investigation, it reveals that, the petitioner, a student at the same college, has created a fake Instagram account under the name ‘\_Aswiniii\_pvt’ and he downloaded photos of 30 girls who are studying in the said college and used AI prompts to create manipulated, nude images of them and later, 24 of the students found their photos were posted in Instagram and they reported about the same to the defacto complainant and based on the same, the defacto complainant lodged complaint. Investigation is still pending.

5. After considering the submissions, considering the nature of offence, though the petitioner is in judicial custody for the past 36 days, considering the nature of allegation leveled against the petitioner, as investigation is still pending, this Court is not inclined to grant bail to the petitioner.

**Hence, this petition is dismissed.**
