These petitions came before me for final hearing on today in the presence of **Tvl.N.R.Vikram, C.Ganesh Pandian and A.Shabanal**, Advocates for the Petitioner in GWOP No.140/2023, and **Thiru.A.Shridhar Murthy**, Advocate for the Petitioner in GWOP No.206/2023 and upon perusing the relevant records and having stood over for consideration till this day, this Court passed the following

**COMMON ORDER**

**GWOP No.140/2023**

The Petitioner namely S.Anitha, who is the maternal aunt of the minor, has filed this petition under Sections 7 and 10 of the Guardian and Wards Act 1890, seeking for appointment the Petitioner as the Guardian of the Minor Yajnesh Swarun.

**GWOP No.206/2023**

The Petitioner namely Ananthi S, who is the another maternal aunt of the minor, has filed this petition under Sections 7 and 10 of the Guardian and Wards Act 1890, seeking for appointment the Petitioner as the Guardian of the Minor Yajnesh Swarun.

Both the cases are filed by the maternal aunts separately seeking for appointment as the Guardian of the minor Yajnesh Swarun, who born on 22-08-2007. Initially, the cases were filed before the District Court, Karaikkal. Thereafter, as per the order dated 28-09-2022 passed in Tr.CMP No.749/2022 by the Hon'ble High Court, Madras, the petition in GWOP No.4/2021 from the file of District Court, Karaikal was transferred to the file of this Court and re-numbered as GWOP No.140/2023. Subsequently, as per the order dated 12-01-2023 passed in CMP No.13440/2022 in Tr.CMP No.781/2022 by the Hon'ble High Court, Madras, the petition in GWOP No.2/2022 from the file of District Court, Karaikal was transferred to the file of this Court to be tried with GWOP No.4/2021 (New number assigned as GWOP No.140/2023) and the said GWOP No.2/2022 has been re-numbered as GWOP No.206/2023.

On 18-06-2024, based on the memo filed both sides, joint trial has been fixed in GWOP No.140/2023. In GWOP No.140/2023, though the Respondents in GWOP No.140/2023 filed their counter statement, subsequently they have not come forward to cross examine the PW1, hence they were called absent and set ex-parte on 14-08-2025. In GWOP No.206/2023, the Respondent in GWOP No.206/2023 filed her counter statement.

This Court perused the records. On perusal of the records, it reveals that, the minor Yajnesh Swarun was born on 22-08-2007. As of 22-08-2025, the

minor has attained the age of majority. In view of the same, the relief sought for appointment of a Guardian to the person of the minor has become infructuous. Therefore, both petitions in GWOP No.140/2023 and GWOP No.206/2023 have become infructuous and are hereby dismissed.

**In the result, both the petitions are dismissed as infructuous.**
