This petition has been filed through **e-Filing** on behalf of the petitioner to release him on anticipatory bail u/s.482 of BNSS.

This petition is coming on this day for final hearing before this Court in the presence of **Tvl. R. Manimuthu, K.Sakthivel, B.Kanisha and S. Priya Dharshini**, Advocates for the Petitioner / A-4 and upon perusing the petition submitted and reply submitted by the respondent police on behalf of the State and upon hearing the arguments, this Court pronounced the following:-

ORDER

Heard both sides.

The petitioner is the accused in Crime No.229/2026 of D5 Sundarapuram Police Station, since he is apprehending arrest in the hands of the respondent police for the alleged offences u/s. 12 TNG Act and 112 of BNS, he has filed this petition, seeking grant of anticipatory bail.

2. The learned counsel for the petitioner has submitted that there is no nexus between the petitioner and the alleged offence. The petitioner is the owner of the subject godown. On the date of the alleged occurrence, after looking after the work as

usual, his workers namely the co-accused were sleeping, at that time, the police came and took them for enquiry under suspicion and the police seized their salary amount and registered this false case only for statistical purpose. In this case, co-accused were enlarged on bail by the learned Judicial Magistrate, Madukkarai in CMP No.538/2026 on 03-07-2026. The petitioner is ready to cooperate with the investigation and he will neither abscond nor tamper the witnesses and he is ready to abide any conditions imposed by this Court and prays for grant of anticipatory bail to him.

3. The respondent police filed a detailed reply and reported that, in this case, a deck of 52 playing cards used for gambling and a sum of Rs.18,500/- have been seized from the accused and all the other accused are in judicial custody and the petitioner is still absconding.

4. This Court has considered the submissions made by both sides. The petitioner is arrayed as A-4 in Crime No.229/2026 of D5 Sundarapuram Police Station and on the date of occurrence, he along with the other accused is stated to have involved in gambling. Considering the submissions, taking into consideration the facts and circumstances of the case, the nature of the allegations, and the fact that the co-accused have been enlarged on bail, this Court is inclined to grant anticipatory bail to the petitioner, however, on condition that the petitioner deposits a sum of Rs.15,000/-, **hence this Court is inclined to grant anticipatory bail to the petitioner subject to the following conditions:-**

(i) Anticipatory bail is granted to the petitioner.

(ii) The petitioner shall execute a bond for Rs.10,000/- in the event of his arrest or the petitioner shall surrender before the District Munsif cum Judicial Magistrate Court, Madukkarai and execute a bond of Rs.10,000/- within 15 days from the date of this order, failing which the anticipatory bail granted to the petitioner shall stand automatically cancelled.

(iii) The petitioner shall produce two sureties for likesum each to the value of Rs.10,000/- each to the satisfaction of the District Munsif cum Judicial Magistrate Court, Madukkarai within 15 days from the date of this order, failing which the anticipatory bail granted to the petitioners shall stand automatically cancelled.

(iv) The petitioner is directed to deposit a sum of **Rs.15,000/- [Rupees Fifteen thousand only]** to the credit of the same in Crime No.229/2026 of Sundarapuram

Police Station, before the District Munsif cum Judicial Magistrate, Madukkarai at the time of producing sureties.

(v) The sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar Card or Bank Pass Book to ensure their identity.

(vi) The petitioner is directed to sign before the respondent police, daily at 10.00 a.m. for a period of 30 days.

(vii) The petitioner shall not abscond either during investigation or trial.

(viii) The petitioner shall not tamper with evidence or witness either during investigation or trial.

(ix) On breach of any of the aforesaid conditions, the learned Magistrate / Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate / Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji /vs/ State of Kerala [(2005) AIR SCW 5560]**.

(x) If the accused thereafter abscond, a fresh FIR can be registered under Section 269 of BNS.

(xi) Final order in respect of the deposit amount will be passed by the trial Court in the final judgment / order.
