1. That the petition be and the same is hereby allowed;
2. That the suit in O.S.No.559/2024 which is pending on the file of the Principal District Munsif, Coimbatore, be and the same is hereby ordered to be withdrawn and transferred to the file of I Additional District Judge, Coimbatore;
3. That transferee Court shall decide whether the suits [O.S.No.559/2024 and O.S.No.1202/2023] are to be tried jointly or simultaneously;
4. That there shall be no costs in this petition.
