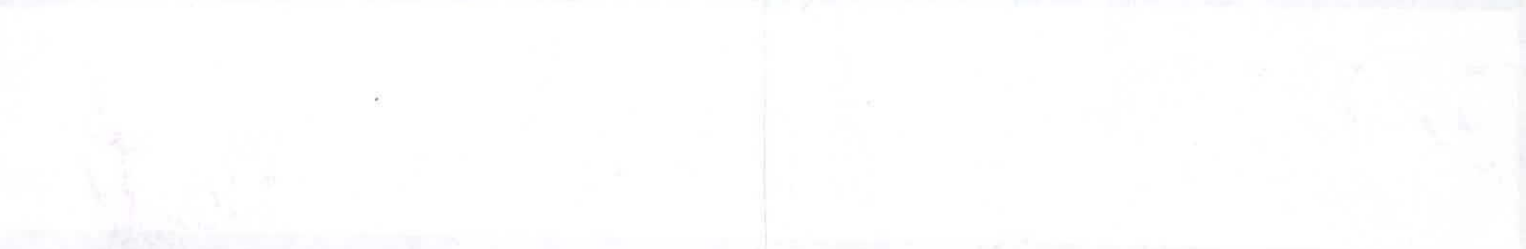

TERMS OF SETTLEMENT
