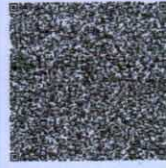





TERMS OF SETTLEMENT
