2. That the petitioner entitled to withdraw the full award amount.

4. That the 2nd Respondent shall send the award amount to the Hon'ble Sub Ordinate Judge, Coimbatore.

5. That the entire Court Fee paid by the petitioner shall be refunded to the petitioner.



That the 2nd respondent be and is hereby granted 30 days time from this date of payment of the award amount mentioned in clause 1 supra into the Bank Account of this Hon'ble Sub Ordinate Judge, Mettupalayam in the State Bank of India, Main Branch, in Current A/c.No. MTPSUB, IFSC Code : SBIN0004266. Failing which interest should be paid at the rate of 7.5% P.A. from the date of Award till the date of deposit of award amount. As and when the award amount is deposited in the Court the same shall be disbursed to the petitioners through NEFT/RTGS, as per the directions of the Hon'ble High Court of Madras in CMA No.428/2016 in the bank account of the Petitioner.


