This case referred to the Lok Adalat organized by the Coimbatore District Legal Services Authority under section 19 of the Legal Services Authorities Act (Act 39/1987) coming on before us endeavors at settlement of the dispute between the parties, being the subject matter of this case, in the presence of the parties and their counsel, and after a full and frank discussion of all issues factual and legal arising from the case, the parties having agreed before us that there shall be an award/order in terms of settlement hereto made and the parties and their counsel herein having, in acceptance of the same signed this in our presence, it is ORDERD.

AWARD

The Petitioner and the 3rd Respondent are present. On negotiation, both parties have agreed for settlement of the dispute for a sum of Rs.10,55,000/- (Rupees. Ten Lakhs and Fifty Five Thousand only).

The 3rd Respondent the insurer of the vehicle agreed to pay **Rs.10,55,000/- (Rupees. Ten Lakhs and Fifty Five Thousand only)** to the Petitioner towards Compensation amount. The Petitioner has agreed to receive this Compensation amount in full quit of her claim in this case.

That the 3rd Respondent shall send the award amount to the Hon'ble Subordinate Court, Mettupalayam. That the 3rd respondent be is and hereby granted 30 days time from this date of order for payment of the Award amount mentioned in clause in 1 supra in to the Bank Account of **The Subordinate Judge Mettupalayam in the State Bank of India, Mettupalayam, Virtual Account – MTPSUB, IFSC Code: SBIN0004266** failing which the 3rd Respondent shall pay interest at 7.5% per annum on the award amount from the date of award till the date of deposit in Court.

As and when the Award amount is deposited in the court, the same shall be disbursed to the Petitioner through NEFT/RTGS, as per the directions of the Hon'ble High Court of Madras in CMA No.428/2016, in the bank account of the Petitioner.

Further that the petitioner is directed to furnish her proof of address, Name of the Bank and its Branch with IFSC Code, Account Number by submitting the first page of the Bank pass book duly attested, Aadhaar Card and PAN card (if any). The Court Fee if any paid shall be refunded to the Petitioner.
