TERMS OF SETTLEMENT

"Both parties are present. On negotiation, both parties have agreed for settlement of the dispute for a sum of Rs. 585000/- only (Rupees five lakhs Eighty five thousands only)) towards full quit of the claim.

The 3rd respondent/s is/are directed to deposit the settled amount before the competent court within One Month from the date of this award, failing which the respondent/s agreed to pay interest 7. 5% per annum on the award amount from today till the date of deposit.
