JUDGMENT

Suit is for Partition of the suit schedule properties into 3 equal share and for allotment of one such share to the plaintiff and for separate possession, declaration that the sale deed dated 16.07.2013, document No.4280/2013 on the files of Sub-Registrar, Punjai Puliampatti is void as far as the 1/3th share of the plaintiff and consequential permanent injunction restraining the 2nd defendant, and his agent or anybody from encumbering or alienating the suit property, directing the 16th defendant to conduct detailed enquiry on the mutation of Revenue records of the suit property and to take action on the petition dated 19.12.2013 given by the plaintiff as per law; and for cost of the suit.

Pw1 called absent in the morning. Defendant present. Defendant counsel also present and waiting from 10.30 to 4.00 p.m. Plaintiff counsel reporting in the morning. This case has been pending more than 8 years. Hence suit is dismissed for default.
