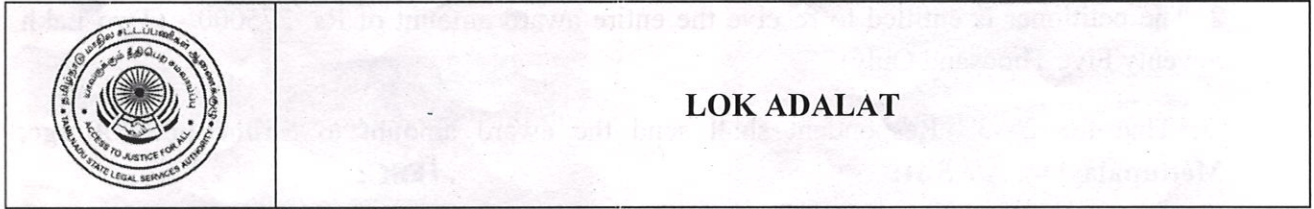

5. That the 3rd respondent be and is hereby granted 30 days' time from this date for payment of the Award amount mentioned in clause 1 supra. Failing which interest should be paid at the rate of 7.5% p.a. from the date of AWARD till the date of deposit of award amount. Each party has to bear their own cost.

6. Further that the Petitioner is directed to furnish the proof of address, Name of the Bank and its Branch with IFSC Code account Number by submitting the first page of the Bank Pass book duly attested, PAN Card and Aadhaar Card.
