2. That the petitioner entitled to withdraw the full award amount. Petitioner is entitled to receive entire share award amount of Rs.23,00,000/- (Rupees Twenty Three Lakhs only) deposit. without any the Respondent shall send the award amount to the Hon'ble Subordinate Judge, Mettupalayam. That the entire Court Fee paid by the petitioner shall be refunded to the petitioner. The 2 to 4 petitioners are given No objection to withdraw their share amount to the 1<sup>st</sup> petitioner.

3. That the 2<sup>nd</sup> respondent be and is hereby granted 30 days time from this date of payment of the award amount mentioned in clause 1 supra into the Bank Account of this Hon'ble Sub
