This Petition came up on 12.06.2025 for final hearing before me in the presence of Thiru.R.Gururaj, Counsel for the Petitioner / 3rd party and Thiru.R.Rajavelavan, Counsel for the Respondents 4, 5, 6 /Defendants 1, 2, 3, Respondents 1 and 2 are dead, Respondents 3, 7, 8, 9 remained exparte and upon hearing both sides and upon perusing the entire case records and having stood over for consideration till this day, this Court doth Order and decreetal Order as follows:

- i. that the petition is partly allowed and the petitioner Pandian is directed to deposit his share of compensation (i.e.) Rs.2,00,0000/- (Rs.1,00,000/- each for the 2nd plaintiff and 3rd plaintiff) on or before 14.07.2025 and to issue notice to the creditors listed in the suit 'B' Schedule within one week by calling upon them to appear and prove their claim by 15.07.2025, failing this petition shall stand dismissed.
- ii. that there be no Costs.
