This petition is coming for hearing before me on this day in the presence of Thiru.S.Krishnamoorthy, Advocate for the Petitioner/Accused and of Public Prosecutor for the Respondent and this Court made the following

ORDER

This petition is filed U/s.483(1)(a) of BNSS to relax the existing condition passed in CrI.M.P.No.227/2026, dated - 27.01.2026 for the offence U/Ss.329, 296(b),115(2), 118(1) and 351(3) of BNS, R/w.4 of TNPWH Act @ 329, 296(b), 115(2), 118(1), 109 and 351(3) of BNS, R/w.4 of TNPWH Act regarding the Petitioner/Accused that the Petitioner/Accused was directed to appear before the **SHO, Tindivanam Town Police Station daily at 10.30 A.M. until further orders.**

The Learned Counsel for the Petitioner/Accused contended that the Petitioner/Accused obeying the condition from 29.01.2026 to till date without fail. It is very difficult to obey the condition because he is the only sole bread winner of his family. He obey the condition for the past 45 days. Last one week he did not able to sign before the concerned station due to ill health. Hence, prays to allow the petition.

Notice was ordered to the Learned Public Prosecutor and he has appeared before this Court and contended that the Petitioner/Accused is obeying the condition regularly for the past 45 days and suitable orders may be passed.

Heard both sides.

Hence, on considering the representations made above, this Court is modified the earlier conditions imposed as ***“the Petitioner/Accused is directed to appear before the SHO, Cuddalore NT Police Station on every 1st day of English Calendar month till charge sheet filed””*** instead of daily at SHO, Tindivianam Town P.S.

Hence this petition is allowed accordingly.
