This petition is coming for hearing before me on this day in the presence of Thiru.N.Udayakumar, Advocate for the Petitioner/Accused and of Public Prosecutor for the Respondent and this Court made the following

**ORDER**

This petition is filed U/s.483 of BNSS for seeking bail.

Prosecution case is that the FIR was registered as against the Petitioner/Accused for the alleged offences punishable U/Ss.108 of BNS for the alleged occurrence on 17.05.2026 and the Petitioner/Accused was arrested and remanded to judicial custody on 18.05.2026.

The Learned Counsel for the Petitioner/Accused has contended that he is an innocent and no way connected with the offence and he is falsely implicated in this case and he has not committed any offence as alleged in FIR. He further stated that he is A4 in this case and he is no way connected with the offence. But he is only friend of A1. The deceased committed suicide. So the Respondent Police falsely foisted a case against him. Hence, prays to allow the petition.

The Petitioner/Accused is in judicial custody for the past 16 days.

The Learned Public Prosecutor contended that the Petitioner/Accused is in judicial custody for the past 16 days only. There is illegal contact between the Petitioner/Accused and the wife of the accused. The offence is grave in nature and the investigation is at early stage. Hence, he has strongly objected to release the Petitioner/Accused on bail.

Heard both sides.

Considering the rival submissions of both sides and considering the strong objection of the learned Public Prosecutor and facts and circumstances of the case and considering that the offence is grave in nature and the investigation is at early stage, I am not inclined to grant bail to the Petitioners/Accused.

***Hence, the petition is dismissed.***
