This appeal suit is filed by the plaintiff seeking to set aside the judgment and decree dated 06.10.2023 passed in O.S.No.4/2019 on the file of Principal Sub Judge, Cuddalore and to allow the appeal suit and to decree the suit as prayed for.

The appellant herein as plaintiff has instituted the suit in O.S.No.4/2019 for recovery of money directing the defendant to pay to the plaintiff a sum of Rs.2,26,000/- with subsequent interest on Rs.2,00,000/- at the rate of 12% interest per annum from the date of plaint till the date of realization and for costs.

Appeal filed on 14.12.2023 and delay condoned 7 days for filing Appeal in I.A.No.8/2024 allowed on 20.06.2024 and taken on file on 25.06.2024.

Value of appeal Rs.2,26,000/- and Court fees paid Rs.6,780/- U/s 22 r/w 52 of Tamil Nadu Court Fees Act.

This appeal is coming on 08.06.2026 before me for final hearing in the presence of Thiru.P.Sathiyaraj, Advocate for the Appellant and of Thiru.K.Kodeeswaran, Advocate for the Respondent and upon hearing the arguments of both sides and upon perusing the case records and having stood over for consideration till this day, this court doth order and decree as follows...

1. that the Appeal Suit be and the same is hereby dismissed.
2. that the judgment and decree passed by the Principal Sub Judge, Cuddalore in O.S.No.4/2019, dated 06.10.2023 are hereby confirmed.
3. that the parties do bear their own costs.
