This suit came before me for final hearing on 30.01.2026 in the presence of Thiru.M.Bhimarao, Advocate for the Petitioner/3rd party and and on perusal of the records and upon hearing Petitioner sides, this court delivers the following.

ORDER

The petition is filed U/s 47 and s.151 of CPC by Karthikeyan claiming to be 3rd Party against R1, R2. R2 is father of Petitioner Karthikeyan.

Main EP.177/2013 in OS.115/2009

i) EA.219/2014 u/s 47 CPC filed by R2 viz Father of Petitioner/ Defendant in OS.115/2009 got dismissed on 28.02.2018

ii) EA.292/2014 u/s 151CPC filed by R2 viz Father of Petitioner/ Defendant in OS.115/2009 got dismissed on 05.10.2020.

iii) EA.197/2014 u/o 21 R 97, 98, 99, 100, S.151 CPC filed by Arputhagandhi viz Wife of R2 Kaliyaperumal got dismissed on 30.08.2024.

iv) Stay Petition EA.85/2023 u/s 151 CPC, U/or 21 R 26(1) filed by Arputhagandhi/claimed as 3rd party viz mother of Petitioner Karthikeyan is pending.

Right now, Son of Arputhagandhi and Kaliyaperumal come with this petition U/s 47 CPC claiming to be 3rd party which is not so as it is evident from material records available before this Court.

Mainly, this petition averments filed by Petitioner Karthikeyan is as same as Petition EA.197/2023 filed u/o 21 R 97, 98, 99, 100, S.151 CPC by Arputhagandhi mother of Karthikeyan with same facts which got dismissed after contest, on merits. On perusal of entire case records,

a) R2 Kaliyaperumal lost his case and no appeal filed against decree dt.08.01.2010.

b) R2 didn't prefer Appeal contesting petition mentioned property to be Mandhaivali poromboke. Importantly, rather filed Petitions in main EP viz EA.219/2014 U/s 47 to declare Decree to be Null and Void and inexecutable which got dismissed on 28.2.2018 and EA.292/2018 filed U/s 151, to declare Decree dt to be Null and Void and inexecutable also got dismissed on 5.10.2020

c) Petition filed by Kaliyaperumal's Wife Arputhagandhi U/s 97 CPC EA.197/2023 got dismissed on 30.8.2024.

d) Right now Petition filed by Kalaiyaperumal's Son viz Karthikeyan is same as averments of EA. 197/2023 filed by his mother which got dismissed after contest on merits as abovesaid.

As, R2 didn't prefer Appeal contesting petition mentioned property to be Mandhaivali poromboke and EA.219/2014, EA.292/2018 filed by him got dismissed. Later, his wife's Petition EA.197/2023 also got dismissed .Stay petition EA 83/2025 pending which was only drag on and right now R2's Son came with the same facts of his mother in EA.197/2023 which was decided on merits. On considering above all, this Court rejects the petition as there seems no merits but only drag on .
