ORDER

The petitioners are the plaintiff and the respondents are the defendants. The original suit was filed for the relief of declarations and permanent injunction. Pending the suit, the petitioners filed IA.No.3/2020 and IA.No.7/2022 for the relief of temporary injunctions. In the meanwhile, the 1st defendant died on 2.6.2022. IA.No.8/2023 was filed to implead his legal heirs as 7th and 8th defendants and it was allowed on 10.1.2024. In consequence of the same, the present petition is filed to amend the IA.No.3/2020 and IA.No.7/2022. Considering the facts and circumstances of the case this court is inclined to allow the application

In the result, the petition is allowed. No cost.
