DECREE

- 1 that the defendants be and the same are hereby directed to pay a sum of Rs.31,98,552.92 to the plaintiff with interest at the rate of 12% p.a., from 01.03.2014 till the date of realization;
- 2 that the defendants be and the same are hereby directed to pay a sum of Rs.2,39,897.50 towards the cost of the suit to the plaintiff.
